MEMBERSHIP APPLICATION

- Regular Member (\$175 + Entrance Fee* – Includes NSPS Dues):** Any person holding a registration as a Professional Land Surveyor in the State of Nevada.
- Non-Resident Regular Member (\$175 + Entrance Fee* – Includes NSPS Dues):** Any person holding a registration as a Professional Land Surveyor in the State of Nevada that resides outside the state.
- L.S.I. Member (\$60 + Entrance Fee*):** Any person holding a certificate as a Land Surveyor Intern.
- Corresponding Member (\$120 + Entrance Fee* – Includes NSPS Dues):** Any person holding a registration as a Professional Land Surveyor in a different state (not licensed in Nevada).
- Associate Member (\$60 + Entrance Fee*):** Any person who relies on the fundamentals of land surveying.
- Student (\$25 + Entrance Fee*):** A student who is actively pursuing a survey-related education.
